## **POWERSHOT CIRCLES :: TERMS AND CONDITIONS**

Clear boundaries mean we're all on the same page and can get down to the business of helping you step in to more of your power, to create what you want for your life.

In signing up to take part in the Powershot Circles program you agree and accept the following terms and conditions:

- a. I understand that Tricia Karp and Wise Talk Pty Ltd are not and will not be liable for any actions or inaction, or for any direct or indirect result of any services provided
- b. I understand that I am responsible for creating and implementing my own physical, mental and emotional wellbeing, decisions, choices, actions and results
- c. I understand that coaching and mentoring aren't therapy and don't substitute for therapy if needed
- d. I understand that the services offered by Tricia Karp and Wise Talk Pty Ltd and the content exchanged during the group coaching and mentoring sessions are not professional advice by legal, mental, medical or other qualified professionals and I will seek independent professional guidance for such matters
- e. I agree to engage in Tricia Karp and Wise Talk Pty Ltd's Powershot Circle comprising 6 x 90-minute meetings once a month for a period of six months, plus 3 x 45-60 minute personal coaching sessions if I select this option
- f. I agree to communicate honestly, be open to feedback and assistance and create the time and energy to participate fully in the program
- g. I understand that this agreement is valid as of 29 March 2018. The total fee for participating in the Powershot Circle program is: Powershot Circle only (1) \$1500 + GST and Powershot Circle + 3 coaching sessions (2) \$2195 + GST. Total payment of the fee with a payment plan is (1) \$1650 + GST and (2) \$2414.50 + GST
- h. I understand that by enrolling in the program I am committing to participate in the entire six-month program and that no refunds will apply if I elect to withdraw. If I am unable to attend for a period due to illness, I understand that the terms will be renegotiated on a case-by-case basis at the absolute discretion of Tricia Karp and Wise Talk Pty Ltd

- i. I understand that private coaching session dates will be determined by Tricia Karp and me, based on mutually agreed times. I agree to initiate all scheduled calls and will call
- j. All aspects of the Powershot Circle program relationship, as well as all information (documented or verbal) that is shared in the group and individual sessions are bound to confidentiality but is not considered a legally confidential relationship. I understand that Tricia Karp and Wise Talk Pty Ltd will not disclose any information without my consent
- k. I understand that during the Powershot Circle sessions Chatham House Rules will apply so as to protect the confidential information shared by all participants. I agree to abide by Chatham House Rules for the term of the program
- l. I understand that it is my responsibility to notify Tricia Karp at least 24 hours in advance of any scheduled private coaching appointments if I am unable to attend. Rescheduled appointments will not be available if notice is given within 24 hours. Missed appointments also will not be rescheduled
- m. Except as expressly provided in this agreement, I understand that Tricia Karp and Wise Talk Pty Ltd make no guarantees or warranties, express or implied. In no event will Wise Talk Pty Ltd or its representatives be liable for consequential or special damages
- n. If a dispute arises out of this agreement that cannot be resolved by mutual consent, the parties agree to mediate in good faith
